The minimum payment period is one month. Residential Customers may select GCI Passport International rates in lieu of Basic International Rates, in Table 3.8.

This plan only includes Dial Station and GCI Calling Card calls.

Description:

This plan offers flat, per minute rates by international locations, 24 hours a day, seven days a week. At the time of enrollment, the customer has to select specific international location(s) to be eligible for the rates listed below. Rates are from Alaska, Lower 48, Hawaii and U.S. Territories to designated International locations.

For one pre-selected international location, there is no monthly membership fee. For \$2.00 per month the customer may add a second pre-selected International location. For \$4.00 per month the customer may add a third pre-selected International location. Calls made to all other International locations will be rated at Basic International rates in Table 3.8.

Calling Card rates will be the same as Dial Station rates with a \$.30 per call surcharge.

Domestic Interstate Dial Station rate is .19 as referenced in the Passport Plan, Section 3.1.6(Q). Domestic Calling Card rate is .19 with a .30 per call surcharge as referenced in the Passport Plan, Section 3.1.6(Q).

The Intrastate Dial Station rate is \$.19 as referenced in the Passport Plan, Section 4.2.27.

The Intrastate Calling Card rate is \$.19 with a \$.30 per call surcharge as referenced in the Passport Plan, Section 4.2.27.
